RESOLUTION NO. 17-203

RESOLUTION AUTHORIZING THE CITY MAYOR TO ISSUE A MORATORIUM RELATIVE TO THE OPERATION OF PEDICAB/TRISIKAD FOR HIRE PURPOSELY FOR THE THOROUGH STUDY OF THE CITY’S TRAFFIC CONGESTION PROBLEM

WHEREAS, the number of pedicab/trisikad for hire is continuously increasing, thus causing traffic congestion at the city streets;

WHEREAS, it is the consensus of this Body through the SP Committee on Public Utilities to limit the granting of permits for the above-mentioned utility vehicles up to 1,600 units only;

WHEREAS, in the event that the operator/driver intends not to renew his/her permit during the renewal period or opted to have his/her permit cancelled, the new applicant/applicants over and above the 1,600 could fill-in the vacancy on a **“first come, first served basis,”** hence waiting **list** for this purpose should be maintained with corresponding contact numbers of applicants for ready reference;

NOW, THEREFORE, on motion of Hon. CARMONA, duly seconded by Hons. GUSTILO, MANSUETO and VILLARANTE, it was,

RESOLVED, to authorize the City Mayor to issue a moratorium relative to the operation of pedicab/trisikad for hire purposely for the thorough study of the city’s traffic congestion problem.

RESOLVED FURTHER, to direct the City Treasurer's Office (Business Permits and Licensing Office) to coordinate with the Office of the Sangguniang Panlungsod for the effective implementation of this moratorium.

RESOLVED FINALLY, to furnish copies of this resolution to the City Mayor, City Legal Office and City Treasurer (BPLO) for their information and appropriate action.
