ORDINANCE NO. 15- 06

AN ORDINANCE IMPLEMENTING THE PARTIAL REORGANIZATION OF THE ORGANIZATIONAL STRUCTURE AND STAFFING PATTERN OF THE CITY GOVERNMENT OF SAN CARLOS, NEGROS OCCIDENTAL, PURSUANT TO SECTION 76 OF R.A. 7160 AND R. A. 6758

Introduced by Hons. DEBULGADO and CARMONA

Be it ordained by the Sangguniang Panlungsod of the City of San Carlos, Negros Occidental, in regular session assembled, that:

SECTION I. This ordinance is enacted to partially re-organize the organizational structure and staffing pattern of the City Government of San Carlos pursuant to R.A. 6758 and Section 76 of R.A. 7160, otherwise known as the Local Government Code of 1991:


SECTION 2. The City Government's organizational structure and staffing pattern shall have to be revised incorporating therein Section 1 of this Ordinance.

SECTION 3. **Repealing Clause.** All ordinances, rules and regulations, or parts thereof, in conflict with, or inconsistent with any provision of this ordinance, are hereby repealed, amended or modified accordingly.


SECTION 4. **Effectivity.** This ordinance shall take effect on the day after copies of the duly approved ordinance shall have been posted, for a period of not less than fifteen (15) days, in the bulletin board at the entrance of the San Carlos City Hall and in, at least, two (2) conspicuous public places in the local government unit, not later than five (5) days after approval hereof.


