**EXPLANATORY NOTES**

**WHEREAS**, Ordinance No. 11-01 entitled, ‘AN ORDINANCE REQUIRING COMPULSORY ANNUAL PHYSICAL, LABORATORY, CHEST XRAY AND OTHER EXAMINATIONS FOR THE SAN CARLOS CITY LOCAL GOVERNMENT UNIT PLANTILLA PERSONNEL “ enacted by this Body in 2011, required plantilla personnel of the City Government to submit to some laboratory examinations;

**WHEREAS**, said Ordinance No. 11-01 was amended by Ordinance No. 15-02, entitled, “AN ORDINANCE AMENDING ARTICLE I, SECTION 2 AND ARTICLES III & IV OF ORDINANCE NO. 11-01, “COMPULSORY ANNUAL PHYSICAL, LABORATORY, CHEST X-RAY AND OTHER EXAMINATIONS FOR THE SAN CARLOS CITY LOCAL GOVERNMENT UNIT PLANTILLA PERSONNEL BY PROVIDING ADMINISTRATIVE SANCTIONS FOR NON-COMPLIANCE”;

**WHEREAS**, Ordinance No. 15-02 mandated that all plantilla personnel should submit themselves to the following laboratory examinations:

- Complete Physical Examination
- Chest X-ray PA view
- Complete Blood Count
- Routine Urinalysis
- Routine Fecalalysis (Stool Exam)

**WHEREAS**, it is deemed that for routine fecalalysis (Stool Exam), deworming is being offered as a direct treatment;

**THUS**, this ordinance.

**ORDINANCE NO. 15-07**

**AN ORDINANCE AMENDING ARTICLE III, SECTION 1 OF ORDINANCE NO. 15-02 BY PROVIDING FOR DEWORMING TO BE AN OPTION OF THE REQUIRED ROUTINE FECALYSIS**

Introduced by Hons. BAGUIORO and DEBULGADO

Be it ordained by the Sangguniang Panlungsod of the City of San Carlos, Negros Occidental, in regular session assembled, that:

SECTION I. Article III, Section 1 of Ordinance No. 15-02 is hereby amended to read as follows:

ARTICLE III
ANNUAL COMPULSORY EXAMINATIONS

Section 1. The following annual examinations are compulsory for all plantilla personnel:

- Complete Physical Examination
• Chest X-ray PA view
• Complete Blood Count
• Routine Urinalysis
• Deworming or Routine Fecalysis (Stool Exam), as may be chosen by the plantilla personnel

SECTION 2. REPEALING CLAUSE. All ordinances, resolutions and other issuances that are inconsistent with the provisions of this Ordinance are hereby amended, repealed or modified accordingly.

SECTION 3. EFFECTIVITY CLAUSE. This Ordinance shall take effect upon approval and compliance with the mandatory posting and publication requirement prescribed under R.A. 7160 otherwise known as the Local Government Code of 1991. Copies of this Ordinance shall be sent to the Office of the City Mayor and all City Departments for information, reference and appropriate action.
