**ORDINANCE NO. 15- 09**

**AN ORDINANCE AMENDING SECTIONS 2, 3 AND 4 OF ORDINANCE NO. 14-55 ENTITLED “ AN ORDINANCE PROVIDING FOR THE GUIDELINES, RULES AND REGULATIONS FOR THE IMPLEMENTATION AND OPERATION OF PHASE V OF THE SOCIALIZED HOMELOT PROGRAM OF THE CITY GOVERNMENT FOR QUALIFIED GOVERNMENT EMPLOYEES, SITUATED AT BARANGAY RIZAL, SAN CARLOS CITY, NEGROS OCCIDENTAL AND FOR OTHER PURPOSES”**

**Introduced by Hons. APUHIN and DEBULGADO**

*Be it ordained by the Sangguniang Panlungsod of the City of San Carlos, Negros Occidental, in regular session assembled, that:*

**SECTION 1.** Section 2 (f) and (g) of Ordinance 14-55 is hereby amended to read as follows:

**“SECTION 2. PROGRAM OF ACTIVITIES FOR PHASE V**

- f) The price of the 80 sq.m. lot shall be One Thousand Five Hundred Pesos (P1,500.00) per sq.m. or one hundred twenty thousand pesos (P120,000.00).
- g) Should the applicant/beneficiary avail a lot of more than eighty (80) sq. meters, he/she shall pay the excess area at One Thousand Five Hundred Pesos (P1,500.00) per sq.m. as equity and shall be remitted to SANCARGEM-MPC for the account of the City Government of San Carlos.”

SECTION 2. Section 3 (b) of Ordinance 14-55 is hereby amended to read as follows:

“SECTION 3. BENEFICIARIES

b) Not a registered owner of lot, or owner of conjugal property.”

SECTION 3. Section 4 (b) of Ordinance 14-55 is hereby amended to read as follows:

“SECTION 4. APPLICATION

b) Certification from the OHRM/agency Personnel Officer that the applicant is a permanent/co-terminous/contractual employee of the City Government; certification from their agencies for national government employees. Provided, however, that LGU co-terminous/contractual employees must comply with all the necessary requirements as required by the PAG-IBIG/HDMF with regards to other sources of income.”

SECTION 4. REPEALING CLAUSE. - All ordinances, resolutions and other issuances that are inconsistent with the provisions of this Ordinance are hereby amended, repealed or modified accordingly.

SECTION 5. EFFECTIVITY CLAUSE. - This Ordinance shall take effect upon approval and compliance with the mandatory posting and publication requirement prescribed under R.A. 7160 otherwise known as the Local Government Code of 1991. Copies of this Ordinance shall be sent to the Office of the City Mayor and all City Departments for information, reference and appropriate action.
