ORDINANCE NO. 15- 10

AN ORDINANCE IMPLEMENTING THE PARTIAL REORGANIZATION OF THE ORGANIZATIONAL STRUCTURE AND STAFFING PATTERN OF THE CITY GOVERNMENT OF SAN CARLOS, NEGROS OCCIDENTAL, PURSUANT TO SECTION 76 OF R.A. 7160 AND R. A. 6758

Introduced by Hons. APUHIN, DEBULGADO and CARMONA

Be it ordained by the Sangguniang Panlungsod of the City of San Carlos, Negros Occidental, in regular session assembled, that:

SECTION I. This ordinance is enacted to partially re-organize the organizational structure and staffing pattern of the City Government of San Carlos pursuant to R.A. 6758 and Section 76 of R.A. 7160, otherwise known as the Local Government Code of 1991 :

SECTION 2. The City Government's organizational structure and staffing pattern shall have to be revised incorporating therein Section 1 of this Ordinance.






