WHEREAS, a Clinical Laboratory at the New SCCH is a requirement for hospital licensing by the Department of Health;




RESOLVED, to recommend the creation of a Clinical Laboratory at the New San Carlos City Hospital;

RESOLVED FURTHER, to furnish copies of this resolution to the City Mayor, the New City Hospital, both of this city and the Department of Health for their information.




