**RESOLUTION AUTHORIZING THE CITY MAYOR TO ENTER INTO AND SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF SAN CARLOS, THE MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF AGRICULTURE - REGIONAL FIELD OFFICE (DA-RFO) VI RELATIVE TO THE LATTER'S PROCUREMENT OF ONE (1) UNIT PEANUT GRINDER IN THE AMOUNT OF P88,000.00 UNDER THE HIGH VALUE CROPS DEVELOPMENT PROGRAM FOR SAN CARLOS CITY**

WHEREAS, the Department of Agriculture (DA) has a mandate to facilitate the implementation of agricultural programs/projects in the region by providing logistical, administrative and technical support addressing the local government units' (LGUs) needs and priorities in support to the socio and economic well-being and entrepreneurial skills development of farmers;

WHEREAS, the Department of Agriculture shall procure one (1) unit peanut grinder machine in the amount of P88,000.00 in accordance with R.A 9184 as per approved LGU proposal under the high value crops development program for peanut farmer-growers;

WHEREAS, the City Government of San Carlos is a recipient of the said machine and agrees to enter into a Memorandum of Agreement with DA-RFO VI to continue the high value crops development program for the benefit of peanut farmer-growers in the city;

WHEREAS, the august body found the stipulations in the Memorandum of Agreement in order;

***NOW, THEREFORE, on motion of Hon. ONGTIAOBOK, duly seconded by Hons. CARMONA and UY, it was***

RESOLVED, to authorize the city mayor to sign, for and in behalf of the city government of San Carlos, the memorandum of agreement with the Department of Agriculture-Regional Field Office (DA-RFO) VI relative to the latter's procurement of one (1) unit peanut grinder in the amount of P88,000.00 under the high value crops development program for San Carlos City.

RESOLVED FURTHER to furnish copies of this resolution to the office of the City Mayor, City Legal Officer, City Agriculturist, this city and the Department of Agriculture-Regional Field Office VI, Iloilo City for their information.


