

# **TERMS OF REFERENCE**

#### A. Background

The city government has many building structures that have been used as official venue and functions serving the basic services to the public.

#### B. Objective

Preservation of these building structure is the government concern. Pests like termites destroy the structures and are given a major importance for the preservation of the buildings. In addition, treatment of areas in the building infested by disease transmitting pests like cockroaches, mosquitoes, flies and rodents are considered for the health concern of the personnel and clients of the different offices.

## C. Bidder/Contractor

- The bidder/contractor must be experienced pest controller for a period of ten years or more.

- The bidder/contractor must be a member of Pest Control Association of the Philippines, Pest Control Association of the Visayas and Philippine Federation of Pest Management and Operation Association Inc.

- The bidder must have an office station in Negros Island for easy contact.

- The bidder should have a License To Operate issued by the Food and Drug Administration as Household/Urban Pesticide/Wholesaler.

- D. Scope of Works
  - The use of perimeter baiting treatment and control of termite underground colony. Devices should be installed inside and outside perimeter. Termite Colony Elimination System.
  - General pest control for effective control of disease transmitting pest such as cockroaches, mosquitoes, flies and rodents control management.
  - Treatment of termite inside the building.
  - The contractor must provide to the LGU a conduct of training for the LGU in house personnel for consultation and recommendation (integrated Pest Management Program)
- E. Specification:

- All chemical to be used should be food and drug administration approved and currently registered
- Termites colony elimination and perimeter baiting treatment, devices should be installed in ground station and above ground station. Chemicals to be used (Hexaflumuron 0.5%, Brofanilide 5% W/V)
- Flying and crawling insects elimination by misting and spraying. Chemical to be use (S-Bioalletrin, Permethrin, Piperonyl, Butoxide, Deltamehtrin)
  - For rodents control or elimination by bait for rodents. Chemicals to be used (Diphacinone 0.005%), Mechanical traps, Pipes baits.
- F. Delivery/Completion
  - Work duration is sixty (60) working days.
- G. Manpower requirement

The contractor shall provide an experienced pest control personnel to fully undertake their project.

- H. Others
- The contractors shall provide one (1) year free maintenance on monthly basis for termite monitoring and baiting status of the building premises soil (colony elimination system).
- One year free maintenance of spraying chemical treatment of perimeter cracks and crevices, and rodents baiting in the perimeter depending on the degree of infestation or as requested.
- I. Payment scheme

Payment should be in accordance with RA 9184 and other relevant laws.
