

It aims to connect the theory learned in the classroom, with practical, real life knowledge and experiences

The bidder should have an experience in a construction of at least a two-storey school building for the last 5 years.

## **General Conditions**

- The project is a construction of 2-storey 6-Classroom School building.
- All plans and specifications shall be provided by the end-user.
- The work to be executed in this project shall include the following scope of Works:
  - Mobilization includes setting up Temporary Facility (bunkhouse) and Project Billboard
  - Earthworks includes Structural Excavation and Backfilling with Soil poisoning
  - Concrete Works includes Footings, Tie beams, Slab on fill, Columns, floor beams, floor slab, lintel beams, stiffener columns, and Roof Beams. This also includes the false works (forms and scaffolding) provision.
  - Masonry Works includes interior and exterior CHB Wall with mortar and plastering.
  - Roof Framing involves welding works of C-Purlins rafter, Metal Fascia and Roof Trusses,
  - Roofing works involves the purchase and installation of Pre-painted Corrugated G.I. Roof, pre-painted Ridge Roll, primary and secondary prepainted metal fascia flashing.

- **Ceiling works** involves interior and exterior fiber cement board ceiling on Metal framing. It also includes the installation ceiling vents.
- Tile work Non-skid 30x30cm ceramic Floor tiles and Glossy 30x30cm ceramic wall Tiles for Comfort Room only.
  - Painting works includes Painting of interior and exterior walls on Semigloss paint finish. Painting of exterior and interior ceiling on Flat Latex paint finish. Application of Red oxide metal primer on roof framing materials. It also includes painting works for Doors and stair railings
  - **Doors and Windows** includes the supply and install of Main Panel Doors on Wooden Door Jamb with complete accessories (Loose pin hinges and door locks) and PVC Door for the comfort rooms. Jalouplus windows with Steel window grills.
  - **Plumbing works** involves water supply and sanitary pipelines, Plumbing fixtures (water closet, lavatory, faucet and floor drains), Septic Vault (3 chambers), 2 units Stainless Steel water tank 2000L, Centrifugal pump and Pressure tank with complete accessories.
  - **Electrical works** includes Electrical Fixtures (Lighting and Convenience outlets), Electrical Wires, Conduits and Circuit Breakers.
  - Stairs and Railings construction of Concrete stairs and Fire exit steel stairs with stair Railings.
    - **Chalk Board** fabrication and installation of curved chalkboard on a S4S Wood Frame.
  - Demobilization clearing and cleaning of the project site.




# **Payment Scheme**


