A. Background

The City Government through the City Engineering Department proposed a six-story City Hall Annex Building to cater all offices in one area so that the city can provide swift and prompt services to the Public.

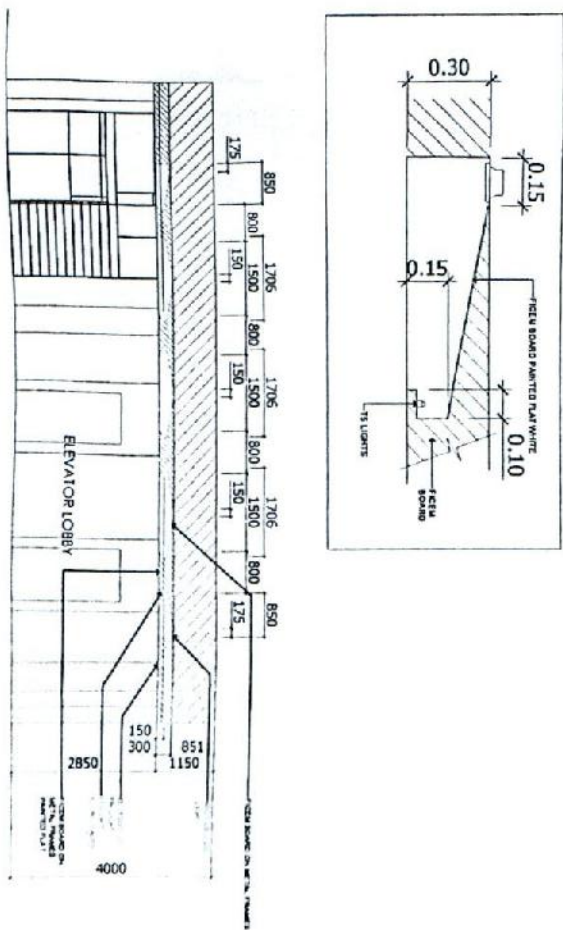
