



A. Background

The City Government of San Carlos through the City Engineering Department proposed a Concreting of Road at Sitio Gigalaman, Barangay Guadalupe For sustainable solution, leading to cleaner air and healthier environment.

B. General Objectives

The primary objective of this project is to provide 650.00 linear meters long, 5.00 meters wide and 0.20 meters thick for main road and installation of 7 pcs. RCPC 36" diameter.

C. The Bidder / Contractor

The bidder should have an experience in any Road Concreting Projects

D. The Requirements

1. CONCRETE POURING PERMIT (CPR)

1.1. A concreting Pouring Permit must be submitted to the Project Engineer every base course prepared for pouring. CPR must be inspected by the MQC and approved by the Project Engineer before the concrete pouring can proceed

2. FIELD DENSITY TEST (FDT)

2.1. A field density Test is conducted by the MQC upon the official request of the Project Engineer thru the Concrete Pouring Permit. FDT must passed the minimum requirements in accordance to the standards and specifications stated in the DPWH Blue Book 2015

3. TESTING OF CONSTRUCTION MATERIALS

- 3.1. Samples of coarse aggregates (75 kg), fine aggregates (50 kg), base coarse (25 kg) and rebars (3 pcs of 1-meter sample for every diameter) must be submitted to the MQC Laboratory for testing.
- 3.2. The Contractor must prepare their own concrete cylinder samples and must have an area secured enough to hold the samples at its curing stage for 28 days without moving or disturbing the samples.

4. REQUIRED COMPRESSIVE STRENGTH

4.1. The strength level of the concrete will be considered satisfactory if the averages of all sets of three (3) consecutive strength test results equal or exceed the specified strength fc' and no individual strength test result is deficient by more then 15% of the specified strength fc'.

5. TESTING FEES

5.1. Testing fees must all in expense of the Contractor

6. FINISHING AND CURING

- 6.1. Curing compound must be immediately applied to the concrete after pouring.
- 6.2. Concrete spans must be cut within 6 to 12 hours after finishing the concrete with A depth of 2" and must be applied with an asphalt sealer after cutting.

7. GEO TAGGED PHOTO ON-SITE

7.1. Geo Tagged Photos must be submitted to the Project Engineer every concrete pouring on-site.

8. PUNCHLISTING

8.1. Punch listing must be attended by the Contractor's Personnel, MQC and by the user.

9. PROJECT BILLBOARD AND EARLY WARNING DEVICE

- 9.1. Project Billboards must be placed at the start and end of the project.
- 9.2 Early warning should also be placed at the start and end of the project for the safety of the public.

Any disagreements regarding technical matter or specifications of the project, both the end user and the contractor must refer to the DPWH Blue Book 2015.

E. Delivery / Completion

Delivery /completion shall be within 210 Working Days.

F. Warranty

Warranty shall be for a period of one year from the turn-over of the completed whole project.

G. Payment Scheme

The city has allocated a budget of Nine Million Eight Hundred Fifty Seven Thousand Four Hundred Forty Pesos (P 9,857.440.00) of the said project. The winning bidder shall be paid in accordance with **R.A. 9184** and other relevant laws.
