

A. Background

Various Public Schools within the City of San Carlos are in need of additional comfort rooms. It was observed that the existing comforts rooms are either in need of repair or inadequate to accommodate the increasing number of students and teachers.

B. General Objectives

The objective of the construction program of the DepEd is to provide the public specifically the teachers and students a well deserved, sanitized and comfortable usage of comfort rooms.

C. The Bidder

The bidder/contractor must have under taken projects similar types to this project in the last 5 years.

D. The Requirements

1. Scope of Works

General Conditions

- The project is a construction of 1-Storey Comfort Rooms (Male, Female and PWD)
- All plans and specifications shall be provided by the end-user.
- The work to be executed in this project shall include Mobilization, concrete and masonry works, Steel and Roofing works, carpentry works, tile works, painting works, doors and windows, plumbing works, Electrical works and Demobilization.
- > The contractor shall make sure that the existing adjacent structures shall be protected from damage during construction.
- All workmanship and materials used in the project shall be of quality standard and in accordance with the technical specifications, plans, and other requirements
- All workmanship, materials and fixtures shall be subjected for inspection by the Engineer /Project in charged that may check and ask for samples of materials to be used for the said project
- Construction safety and health protocols should be observed at all times by the contractor during the duration of the project.
