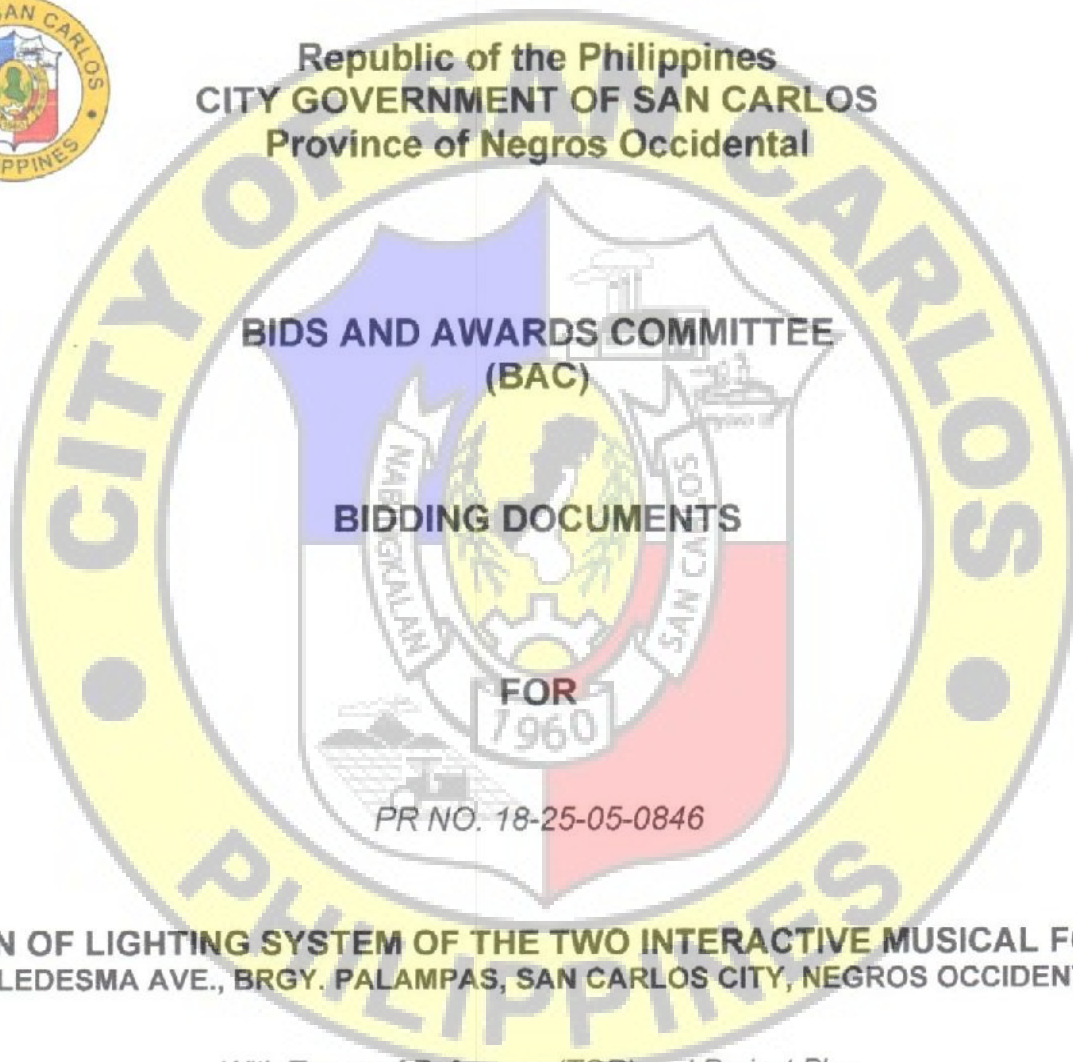



## **I. BACKGROUND OF THE PROJECT**

The City of San Carlos and its new Central Business District known as the "Center Mall" features wide landscaped thoroughfares and open spaces. Adjacent areas to the city's business district are where the location of the City Hall and its open space for the public.

The proposed project features an additional lighting system in the city hall façade, in which it specifically combines architectural lighting with audio synchronization linked to the two existing fountains. With its LED lighting, it causes the lights to flash, pulse, change color, or create dynamic patterns independently or in sync with the music. The project will serve as an additional attraction to the city as it creates a variety of colorful lighting illumination thus, adds excitement and visual interest to outdoor events, festivals and creates memorable experience to the general public.

## **II. GENERAL OBJECTIVES**

The project design concept aims to attract visitors/ tourists with the city hall's additional lighting system on its façade showcasing creative lighting effects with audio synchronization to the existing two interactive musical fountains.

## **III. GENERAL REQUIREMENTS**

The scope of work to be undertaken by the Contractor under this Contract shall include the following:

- o Furnishing of all labor, materials, equipment, tools, and other incidentals necessary to complete in all respect the various items of work involved such as:
  - a. Mobilization, lighting and electrical related works and demobilization.
  - b. Lighting works include uplighting the walls with DMX RGB LED Wall Washer, 108W/220VAC, Control mode: DMX512, Address setting: manual, Beam angle: 60deg.,

Size: 1000 x 58 x 60mm, IP65 and DMX RGB LED Wall Washer, 36W/220VAC, Control mode: DMX512, Address setting: manual, Beam angle: 60deg., Size: 500 x 58 x 60mm, IP65

- c. Electrical works include installation of 2mm<sup>2</sup> X 4C waterproof electrical cables from lighting controller to lights (power and DMX signal);
- d. Linking various conduit sizes complete with fittings and splice boxes from fountain controller to light controller.
- e. Wall mounting the lighting controller complete with micro-PLC control, circuit protection, transformers, Nema3 enclosures, cooling fans and daylight sensor.
- f. Provision of music programming/ choreography in sync to existing musical fountain.
- o The contractor shall set sanitation and safety a high priority during the construction. After completion of Work the Contractor shall remove all temporary facilities and shall restore the temporary facilities area to its original state.
